


# **CONGRESSIONAL APOLOGY FOR SLAVERY**

## **General Order No. 2**

Issued July 28, 2008 Shreveport, LA

In Consideration of the Orders issued by General Robert E. Lee declaring 21 August to be a "day of fasting, humiliation, and prayer," all men are directed to make preparation for such an observation.

By order of:

Charles E. McMichael, Commander in Chief

I support Commander in Chief (CiC) McMichael's General Order. The order to which CiC McMichael refers is General Robert E. Lee's *General Order No.* 83 issued on August 13, 1863. President Davis had appointed the 21 August as a day of fasting, humiliation, and prayer. In his order Gen. Lee stated, "A strict observance of the day is enjoined upon the officers and soldiers of this army." all, to work to achieve harmony within the camp. While an SCV camp is a democratically run organization, the camp commander does have the overall responsibility for the camp he has been elected to serve. The commander presides at all meetings or otherwise designates his subordinate officers to do so. He is nominated for office by a nominating committee, or from the floor. He will appoint all non-elected officers and all necessary committees and will perform such other duties as are usually incident to the office. He will fill all vacated offices occurring during his administration until the next election of officers, with the advice and consent of the camp executive council.

Compatriots, I have served as Commander from 1999-2001 and 2008, and was honored to serve one of the best camps in the Division. I have no desire to serve another year at this time. I would like to see someone assume this position that has fresh ideas and energies and someone that can take our camp to the next level. Please give this consideration and let me or someone on the executive committee know of your interest.

Some 7 weeks after the loss at Gettysburg, Lee sensed that the army, in his words, had "cultivated a revengeful, haughty, and boastful spirit" and was relying "too much on our own arms for the achievement of our independence." As he knew God was their only refuge and strength, he asked the men to confess sin, ask God for courage, convert the hearts of our enemies, and hasten the end of the war. The army observed the day of fasting and prayer in great numbers and it had a great effect.

The challenges our organization and Camp face, both now and in the future, will require such humbleness and reliance on God that Gen. Lee and the Confederate soldier pursued if we are to be truly successful in fulfilling the Charge. All who are able and in good health are encouraged to participate voluntarily. If you do not feel you can devote an entire day to fasting and prayer, then perhaps skipping one meal and spending some time in prayer might be possible. When you begin, if you are like me, give yourself several minutes to get quiet and focus. Many times when I begin in prayer, it takes a little time to clear the issues and distractions of the day, people,

are due. At this writing I have been informed that about 80 compatriots have renewed. This is excellent for August 1 but it still leaves about 120 that have yet to renew. Please see the Adjutant's column below that addresses dues.

Several months ago I mentioned that Compatriot Dennis Todd was in the process of updating the SC Division history in book form. American soil? No, because it serves no purpose.

If it were not for the white West, slavery likely wouldn't have been abolished as soon, if at all. The collective guilt argument (generations removed, no less) simply doesn't wash. White Americans should not feel the least bit of guilt over slavery, any more than black Americans should feel guilty over their own ancestors' transgressions.

Using the logic of identity politics, one could just as easily make the case that black Americans owe white Americans an apology for today's high black crime rate — a very real problem that affects people living in the present yet accusations of "racism" would fly at the mere suggestion. But then again, it is the threat of being called "racist" that compels our leaders to do all sorts of goofy things these days.

There's no reason to believe the men and women on Capitol Hill who bowed at the altar of political correctness last month to apologize for sins they or their constituents never committed will be able to do anything to appease today's unforgiving "slave drivers." # Important Dates in The War for Southern Independence:

Aug. 1, 1861 - Confederate troops skirmish with Apache Indians near Ft. Bliss, TX

Aug. 5, 1862 - Major engagement at Baton Rouge, LA

Aug. 5, 1864 - Battle of Mobile Bay, AL

Aug. 6, 1864 - CSS Tallahassee runs past the Federal blockading fleet and head north to begin raiding northern shipping; destroys 30 ships in two weeks

Aug. 8, 1863 - Gen. Lee offers his resignation as commander of the Army of Northern Virginia. Offer rejected by Pres. Davis

Aug. 9, 1862 - Battle of Cedar Mountain, VA

Aug. 10, 1861 - Battle of Wilson's Creek, MO. Confederates are victorious in the major battle of the war in MO

Aug. 14, 1861 - Brig. Gen. Paul O. Herbert is appointed commander of all the Confederate troops in TX

Aug. 16, 1864 - CSS Tallahassee capture five enemy ships off the coast of New England Aug. 18, 1864 - Petersburg Campaign. Battle for the Weldon Railroad begins three days of

intensive fighting Aug. 24, 1863 - In VA, Gen. Mosby's are active north of the Rappahannock River.

Aug. 25, 1864 - Battle of Reams' Station, VA


Aug. 26, 1862 -Beginning of the Second Manassas Campaign. Confederate Cavalry enter Manassas Junction and capture the rail point, supplies, and prisoners.

Aug. 27, 1862 - Battle of Second Manassas. Troops under Gen. Jackson destroy Federal stores and facilities at Manassas Junction.

Aug. 28, 1862 - For lack of evidence, accused Confederate spy Belle Boyd is released from the Old Capital Prison in Washington

Aug. 29, 1862 - Battle of Second Manassas. The Federal drive against Gen. Jackson's troops end in failure.

Aug. 30, 1862 - Battle of Second Manassas. Gen. Lee's army is victorious


